## **Overseas Employment Tax Credit**

Attach a completed copy of this form to your return to claim the overseas employment tax credit. For more information about this credit, see Interpretation Bulletin IT-497, Overseas Employment Tax Credit.

Before you can complete Part 2 on the back, your employer has to complete Part 1 of this form. If you worked for more than one employer in the year or had more than one qualifying period in the year with an employer (see question A of Part 1 below), have a separate form completed by each employer and for each qualifying period with the employer. If this situation applies to you, contact the Canada Revenue Agency (CRA).

Also if your employment duties, in the period for which the form is being filled, were in connection with two or more contracts under which your employer carried on business outside of Canada, contact the CRA.

Enter the tax year for which you are claiming the credit in the designated box. If your employment period covers more than one year, complete a separate form for each year.

Claiming this tax credit may result in you having to pay alternative minimum tax. To determine if minimum tax applies to you, complete Form T691, *Alternative Minimum Tax*.
